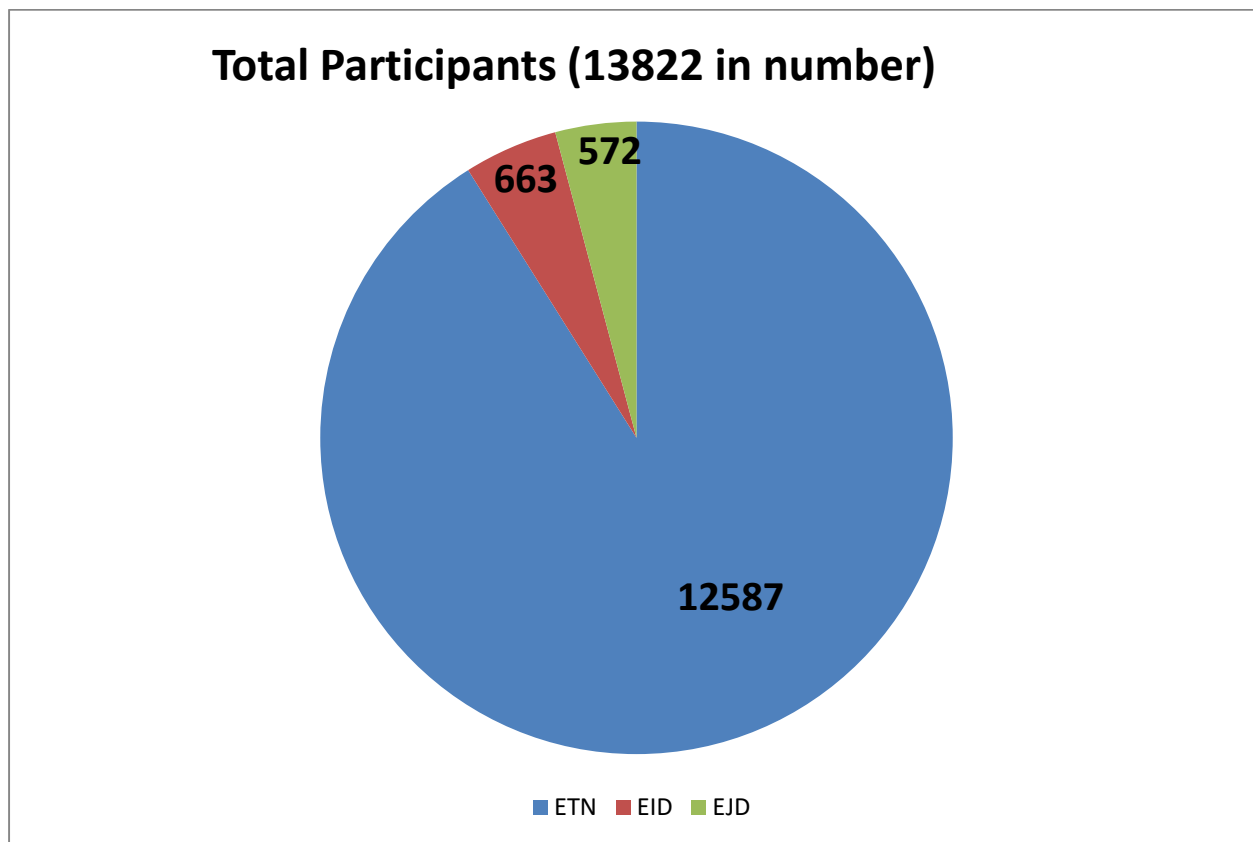

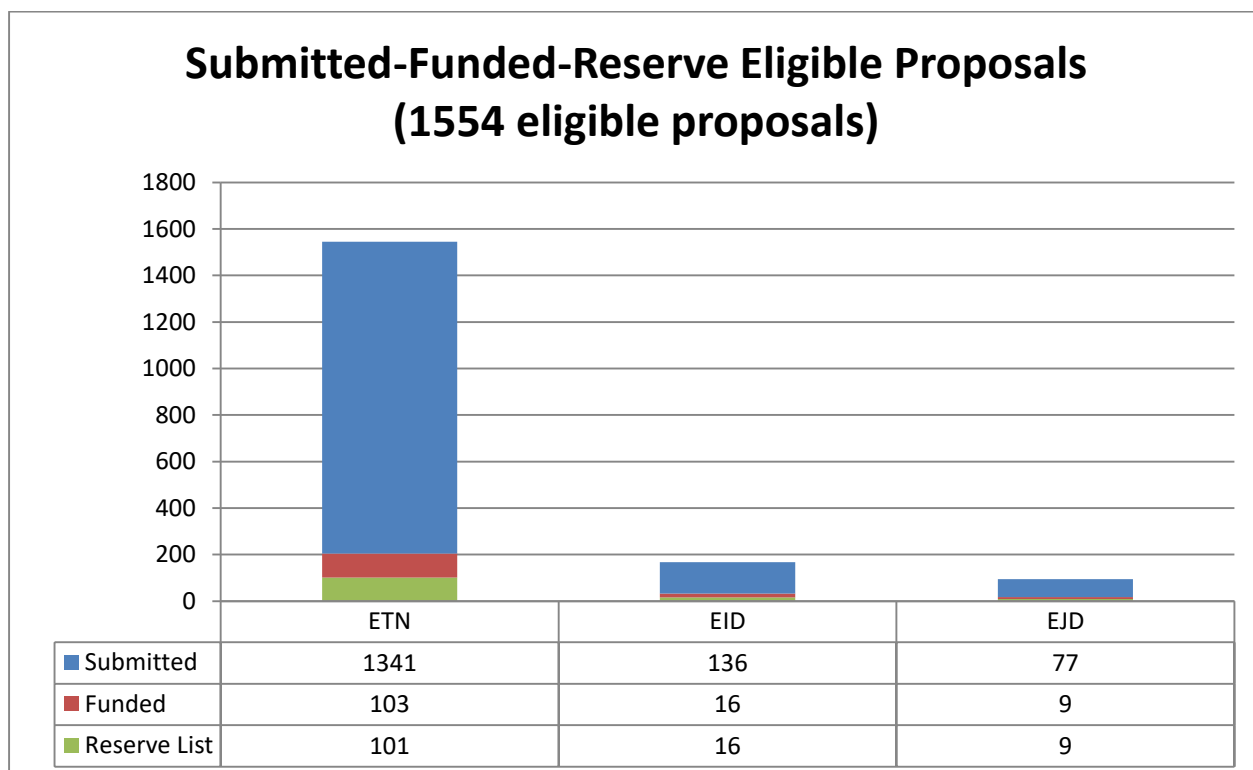

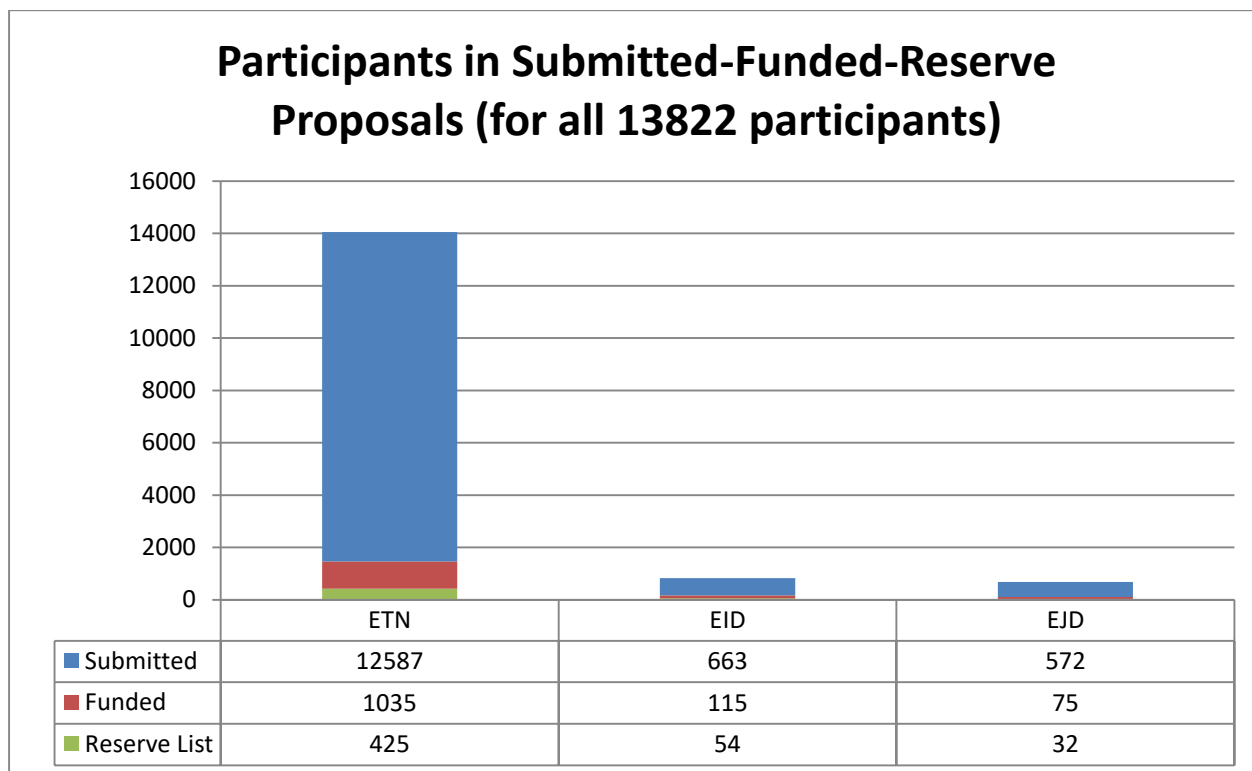

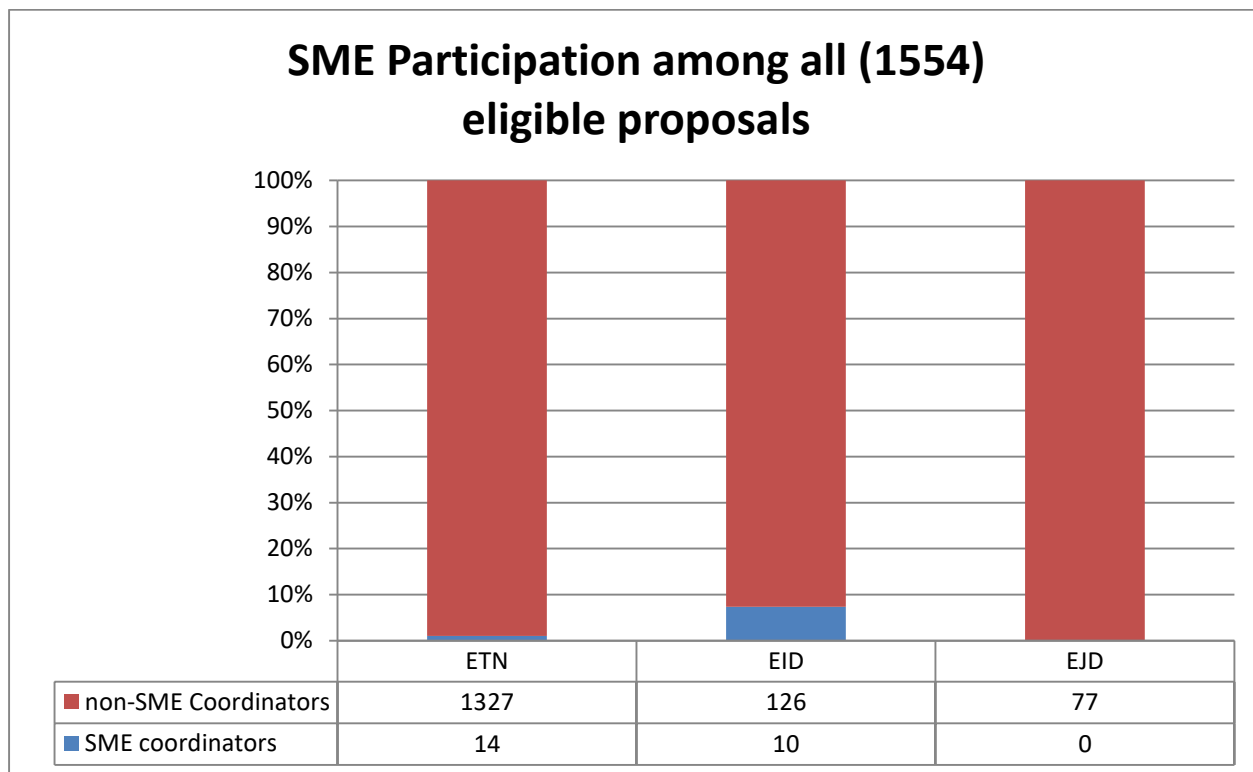

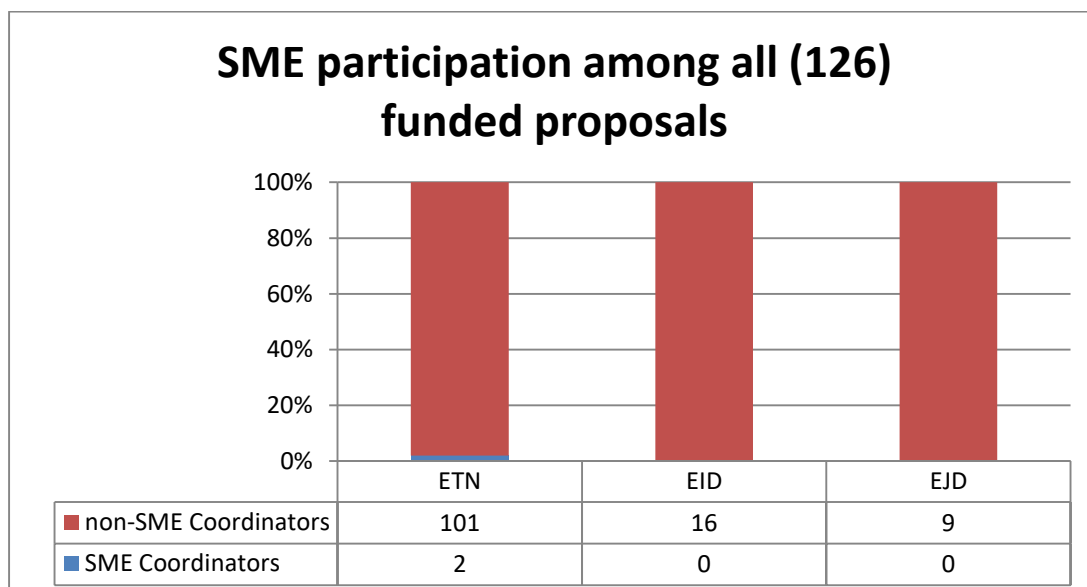

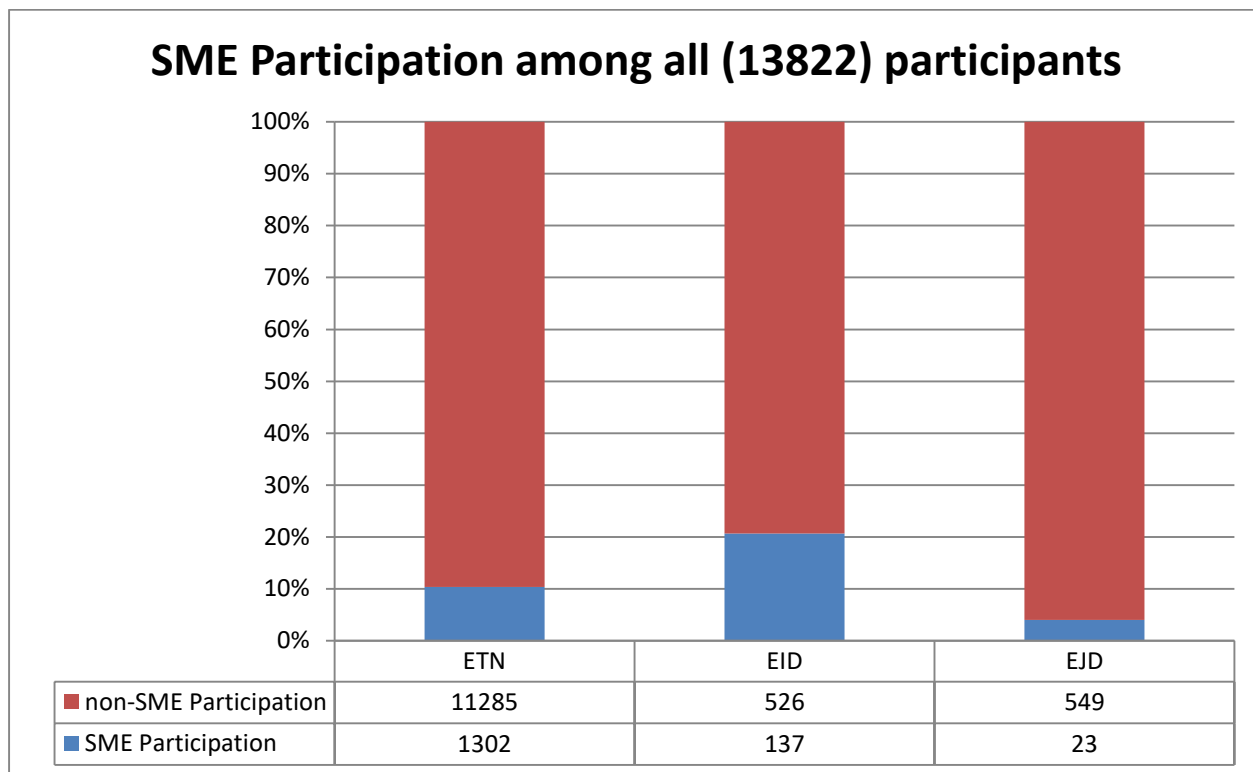
10.SME Participation among all eligible (1554) proposals



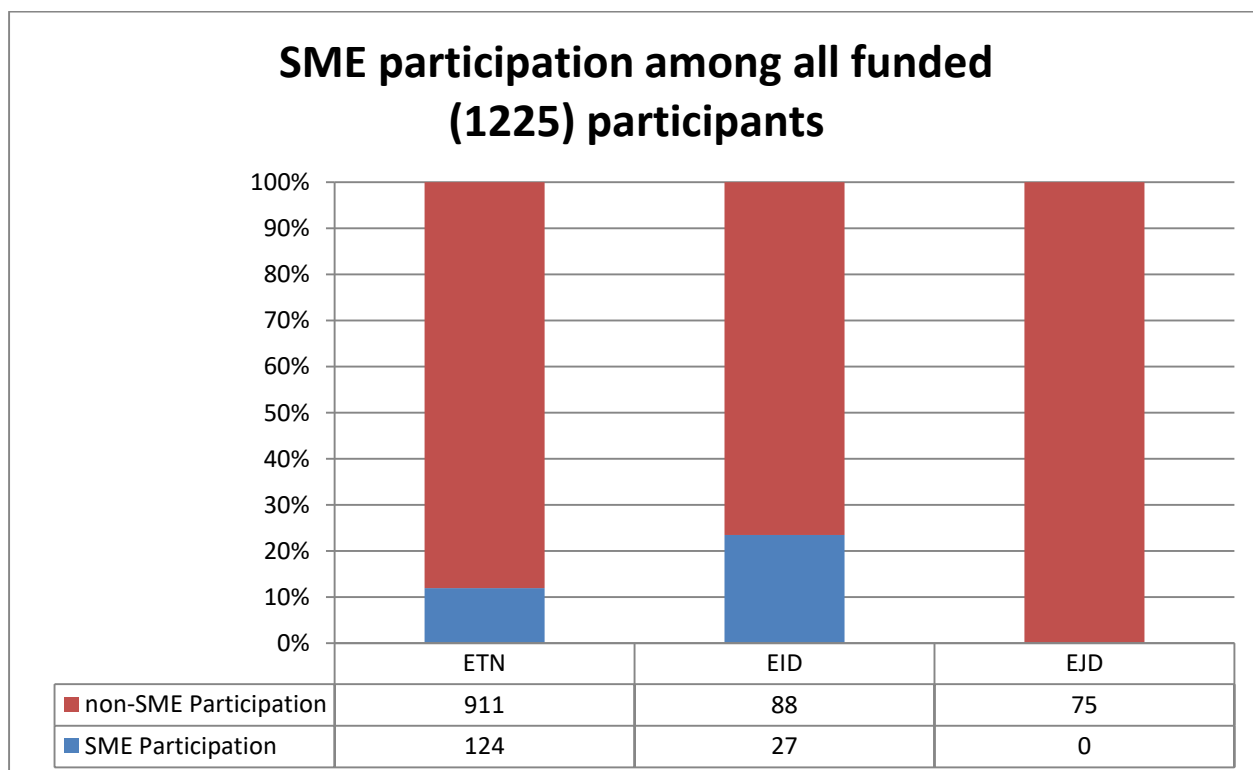
11.SME participation among all funded (126) proposals



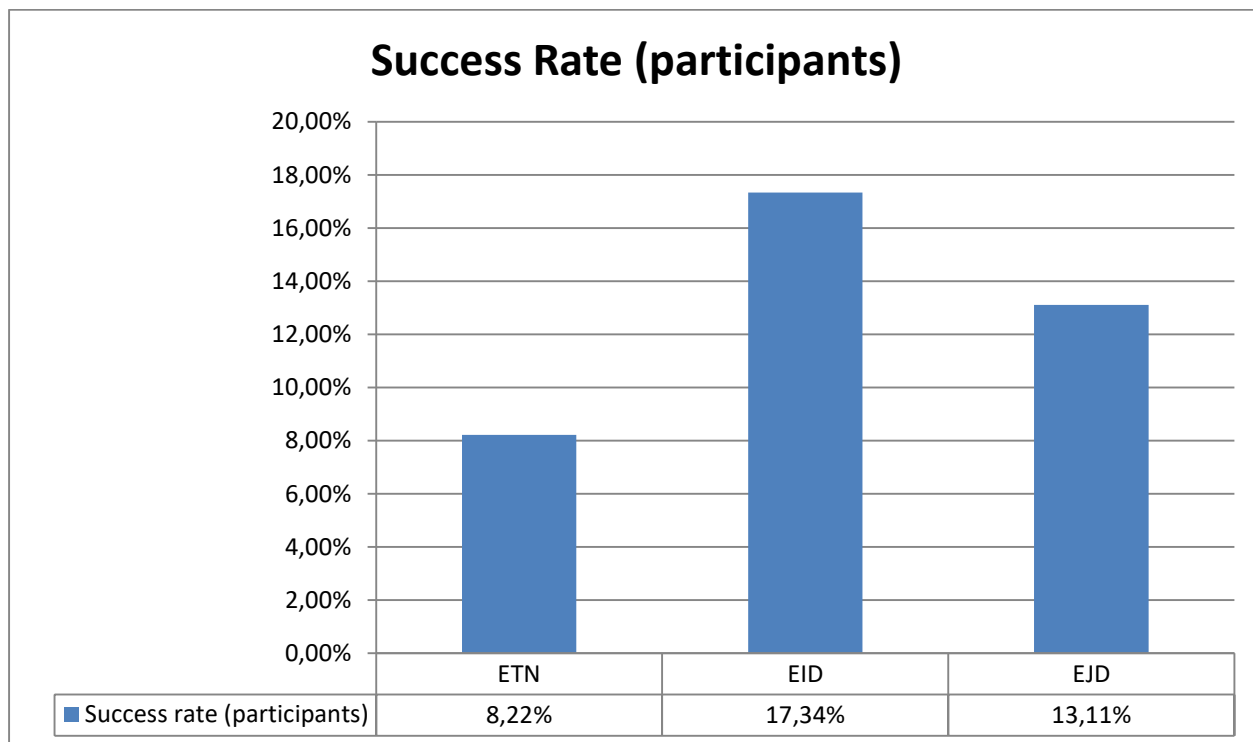
12.SME Participation among all (13822) participants



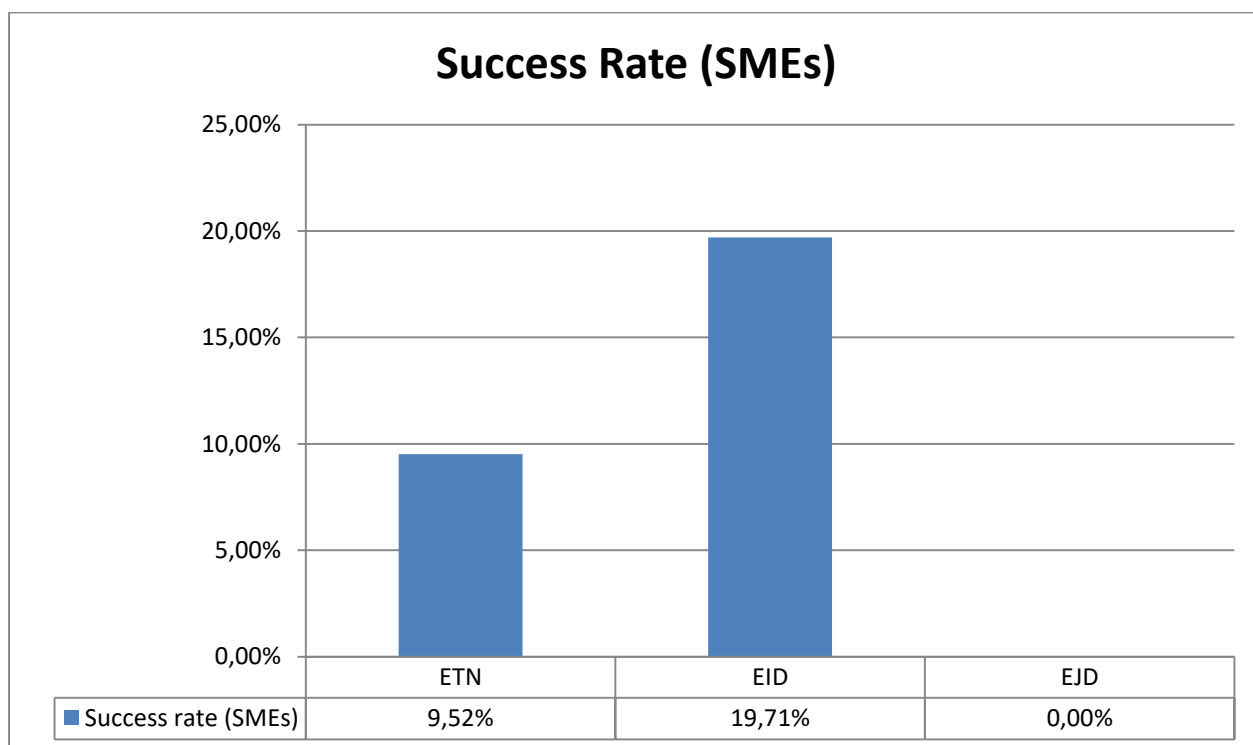

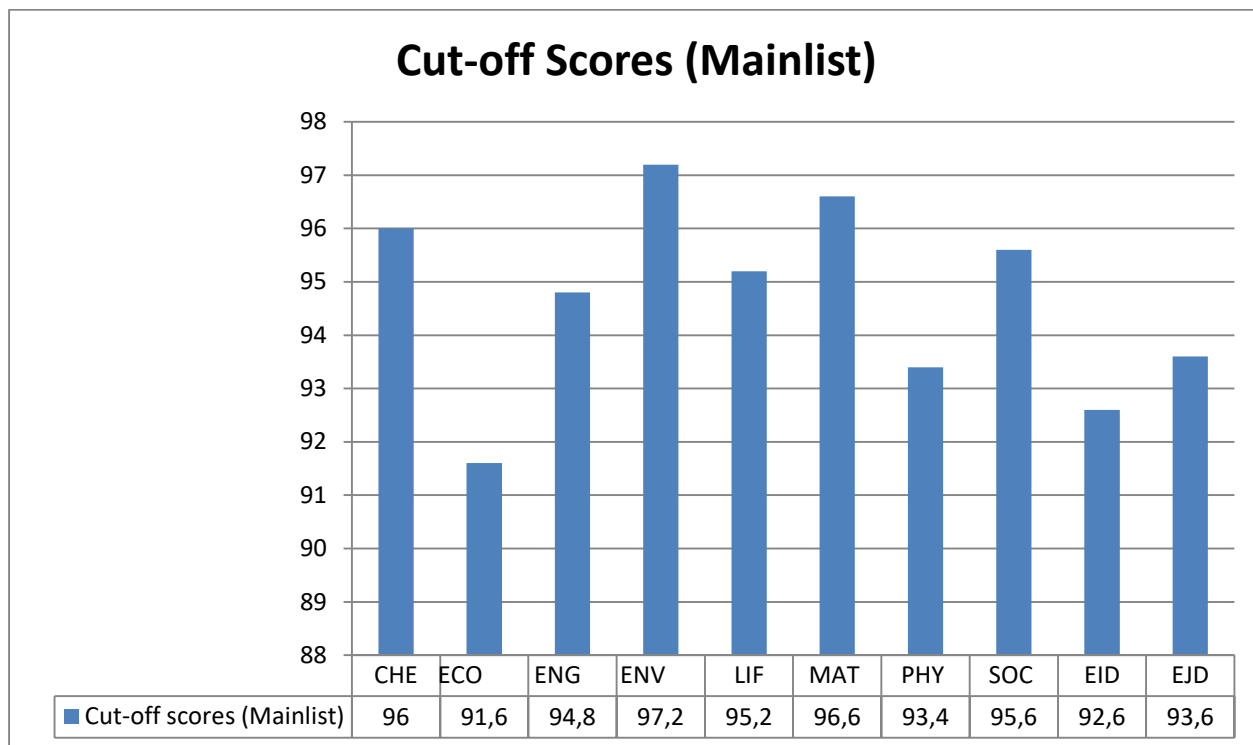

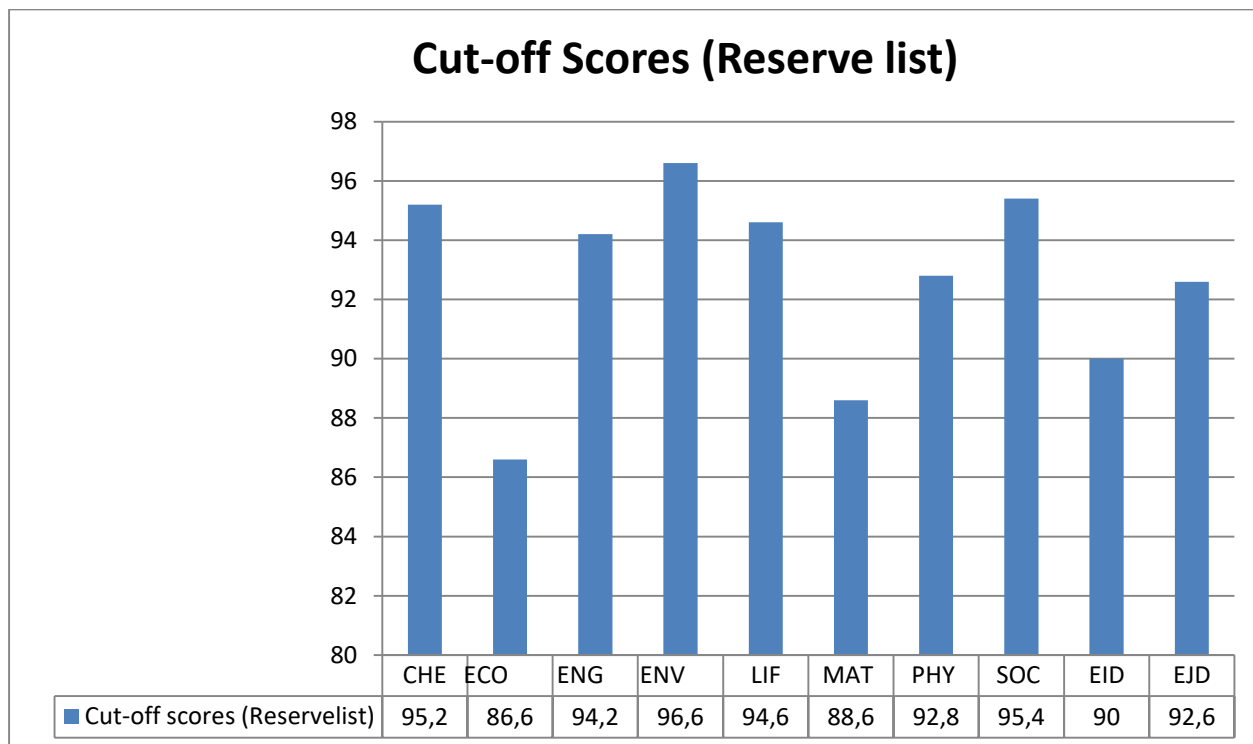

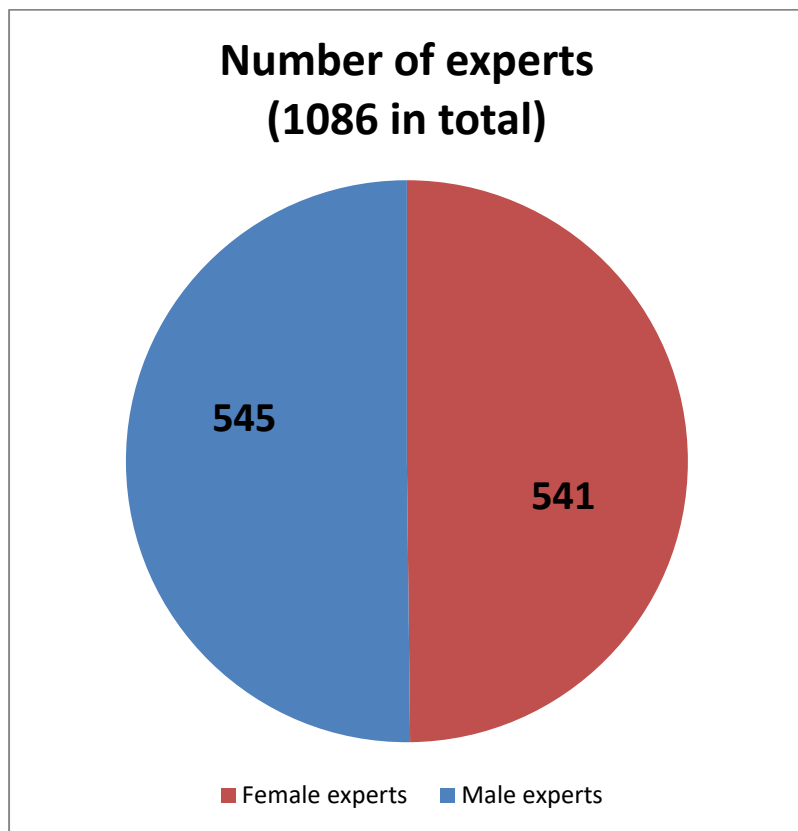
